This article will take you step-by-step through the typical editing processes needed to create a new image in Photoshop. Step 1. Open Photoshop and Create a New File Photoshop is initially run from a disk or a memory card connected to your laptop. You need to have a blank document to work on. To create a new file: Either press the New Document button on the top toolbar or select File → New from the main menu. You will be prompted to specify what the name of the new document will be and you will be given an option to create a new folder. Or, you can create a new file using the New → Blank document command: File → New → Blank document. Now you will be prompted to create the new document, which can be a layer-based composition, a full-page layout, or a document in which the layers are drawn. All Photoshop files are saved in a.psd file extension format. If you're using Photoshop for the first time, leave the "File type" option set to JPEG and choose a file size in the range of 100-200 MB. This will give you plenty of room to create your file. Alternatively, you can open an existing document and adjust the size of the canvas by dragging the top-right corner in the window. Drag the right side, then the bottom edge to adjust the size of the image. Leave it set at 100% or the size of the original file. Note: It's also possible to resize a selected image by pressing the Ctrl+G (⌘+G on a Mac) shortcut, or hold the Shift key while using the mouse scroll wheel. Step 2. Choose the Type of File With the file size and canvas size set, a new document is created. You can choose from different text, graphic, and image file types. A good combination for an image is a combination of an image and a graphic file. If you choose the type of file you want in the next step, it will be ready to save in the format you chose previously in step 1. Step 3. Choose the File Format You can choose the file format for the new document. You can choose from bitmap, color, grayscale, RGB, indexed, and CMYK. You will likely choose bitmap for an image to make it easier to edit. Select Image type: Click

It is well known that the storage of complex fluids, such as viscous or sticky materials, may be aided by inclusion of certain additives that impart additional gel-like properties to the liquid. Generally, these materials may be classified into two types of products, namely, xanthan gums, and derivatives of cellulose, such as xanthan derivatives, e.g. carboxyalkyl hydroxamic acids. Xanthan gum compositions and their methods of use are known in the art. For example, U.S. Pat. No. 4,397,765 to Devall et al. discloses the use of gelled hydrocolloids to enhance the spreading properties of aqueous compositions containing an active ingredient. The hydrocolloids of this invention are water-soluble cellulosic gums, e.g., carboxyalkyl hydroxamic acid gums. Other hydrocolloid materials are disclosed in U.S. Pat. No. 4,152,270 to Brown et al., which discloses polysaccharide gums derived from cellulose, but which are modified by reaction with alkyl mono-carboxylic acids. The modified polysaccharide gums are described as useful in aqueous systems such as shampoos and detergents, and in the preservation of foodstuffs. U.S. Pat. No. 4,552,885 to Merlander et al. discloses the use of hydrocolloids to prepare thickened aqueous compositions, such as fertilizers, medicated powders and foodstuffs. The products are prepared by the addition of at least two polysaccharide gums, which are preferably charged to a "triple-necked, glass-lined" reactor equipped with a mechanical agitator. U.S. Pat. No. 5,433,825 to Horkotic et al. discloses the use of gelling agents to enhance the stability and viscosity of aqueous compositions having organic solvents and pesticidal agents. The preferred hydrocolloids of this invention are derivatized carboxyalkyl hydroxamic acids. U.S. Pat. No. 5,658,955 to Lee et al. discloses a commercial xanthan gum concentrate having substantially non-fibrous fibers. This concentrate is used in manufacturing of dental floss. However, in *Conlin*, the pension policy contained a definition of "accidental death" in its policy, which specifically defined "accidental death" in two ways: (1) one occurring during the course of employment, or (2) one "arising out of the use of the insured automobile." *Conlin*, 973 S.W.2d at 394. Both *Conlin* and the instant case contained this type of policy language providing for coverage for injuries that arose out of the use of the automobile. *Id.* Despite this, the insurance policy in *Conlin* did not contain a definition of "occupying." See *id.* Moreover, the only case law that could have allowed the *Conlin* court to affirm the judgment by virtue of its terms was the 1917 case of *St. Paul Fire and Marine Ins. Co. v. Carr*, 77 Tex. 96, 12 S.W. 656 (1889), overruled on other grounds, *General Acc. Fire & Life Assur. Corp. v. Little*, 526 S.W.2d 592 (Tex.1975). The *Carr* court affirmed the judgment, and stated that a person "occupying" the vehicle at the time of the accident is properly considered the insured. *Id.* at 659 (emphasis added). Even though the general-liability coverage in *Conlin* contained this type of language, the Supreme Court did not make a determination as to whether this language was sufficient to bring the vehicular-assault case within the policy's personal-liability coverage. See *Conlin*, 973 S.W.2d at 394-95 (holding that the policy does not include coverage for assault committed by a passenger, and not addressing the terms of the policy); see also *Kress v. Federated Mut. Ins. Co.*, 34 S.W.3d 886, 895 (Tex.App.-Austin 2000, pet. denied) (recognizing that, for an injury to have been covered under the automobile-liability portion of the insurance policy, the employee must have been the named insured under the policy). Therefore, the fact that the definition of "occupying" the vehicle appears in the standard form does not show that the *Conlin* court was actually analyzing the policy based on the terms and conditions of the policy. See *Conlin*, 973 S.W.2d at 394. *Conlin* provided no guidance as to what "arising out of" means when
